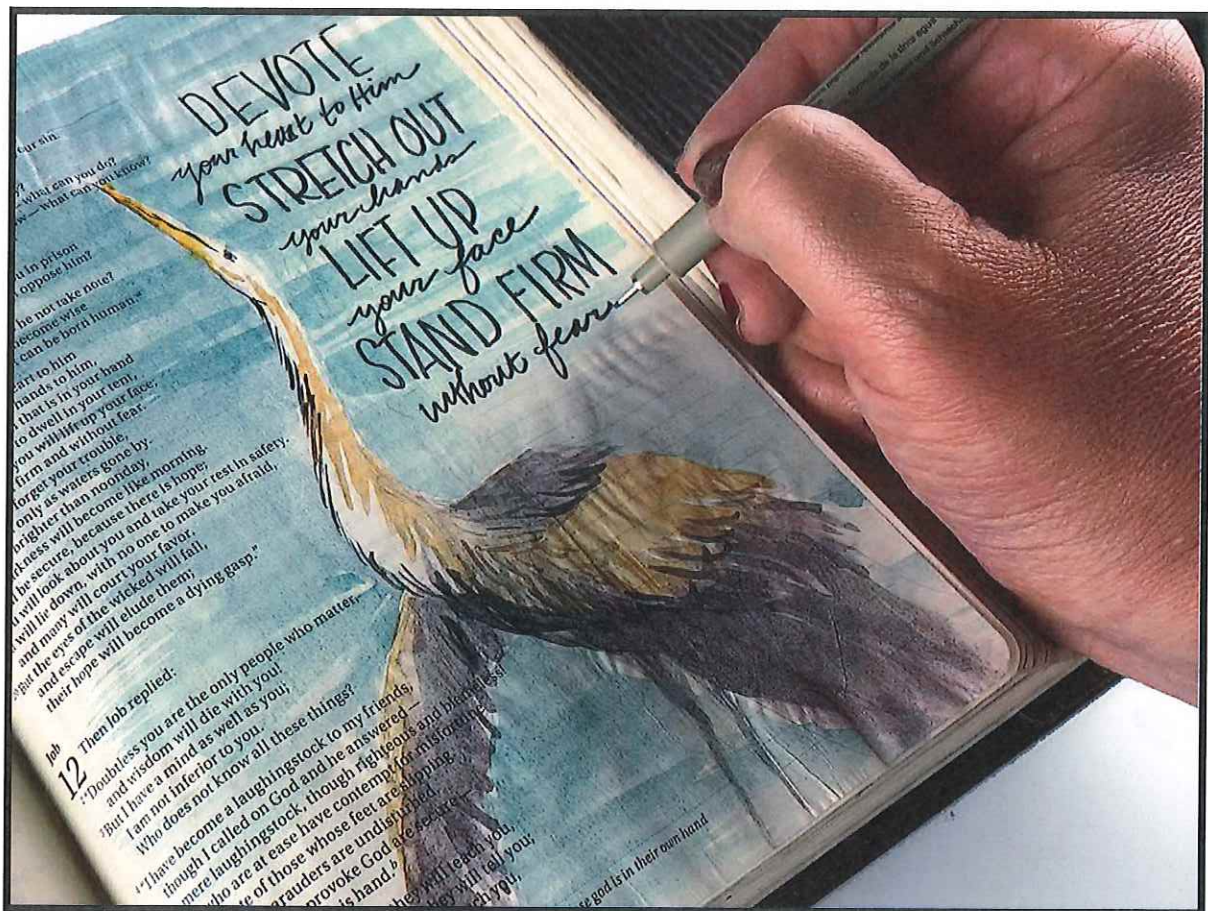

ANNUAL BUSINESS MEETING
July 17, 2021

District Pastor Jerry Davisson welcomed the group and led in prayer, and then Pastor Doug Beisley led in a time of worship.

CALL TO ORDER: Chair Glen Hossler called the meeting to order at 10:17 a.m. He made a correction to the annual report that Mike Kernutt has retired from the council and Gary Johnson is the new corporation secretary.

Tellers appointed were Jeff Foster, Mary Hatch, Dave Shrout, and Patty Deacon.

Total: 77

APPROVAL OF MINUTES FROM August 1, 2020: Lorin Myers moved and Mike Kernutt seconded to approve the minutes from August 1, 2020. Motion carried.

UPDATES AND REPORTS:

All the reports are part of the annual booklet. The following is a highlight of a few of these reports.

Chair report: Even though the Coronavirus has changed our lives, God remains constant. When Sally Ranton and Val Borst stepped down from their jobs at the district office and Paula Wilson was hired, she helped not only in the transition of personnel but also in the moving of the district office from Salem to River Street Church of God in Newberg. The district office building has been leased to a group, New Horizons, who is a home health care provider.

District Pastor Report: During the pandemic, Jerry had a pastor's gathering twice a month via ZOOM. This proved very beneficial.

He is encouraged about what is happening with Gravity Leadership cohort, learning how to listen to the Holy Spirit. Seven from our district have participated in this cohort and most have started cohort groups in their own churches. Oct. 2 and Jan. 29 are dates scheduled for the next two leadership GLA Bootcamps, held at Hoodview Church of God in Woodburn.

Pacific Coast Collective, includes pastors on the West Coast, trying to see how they can work better together. C-4 cohort groups are part of this Collective, which is a resource to help pastors and leaders see how they can be essential to their neighborhood. He shared a video explaining C-4.

Jerry thanked Glen Hossler for his leadership as chair, Paula Wilson as new office manager, Steve Robertson, who donates his time as district treasurer, and Lisa Switzer, Danette Beisley, and Durwood Ranton for their work at Camp White Branch.

Camp White Branch Report: Liza Switzer shared on the progress at the camp. Camps are open this year. Bookings are starting to come in again. There is still maintenance to be done, although much was done during the pandemic. Many have stepped forward to help at the camp, since Leonard and Stacy Meyers, caretakers, were let go because of finances, which were impacted during the pandemic.

Warner Pacific University: Dr. Brian Johnson was unable to be at this meeting but he will be speaking on Tuesday at Willamette Valley Campmeeting.

Financial Report: Steve Robertson gave the financial report, which is part of the booklet. Church contributions are up about 30% over last year. Jason Mitchell moved and Bill Marble seconded to approve the financial report. Motion carried.

Ballot Vote: Items on the ballot are the proposed budget, and two CWB board members, Mike Kernutt and Durwood Ranton. All items passed unanimously.

Jerry asked Larry Wilson, pastor in Medford, and Paula Wilson, to share a little from their hearts.

The meeting adjourned at 11:57 a.m. with Pastor Steve Kufeldt leading in prayer.

DISTRICT PASTOR

During the month of June 2021, I was called upon to serve on the Grand Jury for Multnomah County. During the month of service our Jury heard over 120 Felony cases. Our job was to decide if the District Attorney's office had enough evidence to bring the case to trial. Monday thru Friday I would board the MAX at Gresham station and take the 1-hour commute to downtown where from 9 to 5, most days, our team sat and heard and often saw images of what following sinful desires does to individuals and our community. It was a life changing experience that cause me to re-evaluate my life and ministry.

To make a long story short, through several Holy Spirit led conversations, I was given permission in October by our District Council to reduce my time commitment and pay to half time and to assume the role as pastor of the Rockwood Church of God (also part time). For the past 9 months I have been serving both organizations.

The plan for the Association is to hire other individual/individuals to work alongside me to continue to serve the mission of our District. During the transition a group of leaders from our Association have been working with the Pacific Coast Collective to plot a way to work closer together and hire collectively a person or persons to work on behalf of the churches on the Pacific Coast. This process has taken longer than any of us expected. While we work out the details, I continue to do my best with the help of our Chair Glen Hossler and Office Administrator Paula Wilson to meet the needs of our Association.

I would like to remind our delegates of the role of the district office as we seek to serve our churches during this time of transition. According to our guiding principles.

The district exists to a) assist the local Churches of God in Oregon and Southwest Washington discern and achieve their individual missions, and b) partner with them to minister together in ways that they cannot minister separately. The three priorities the association has adopted are as follows:

- Discipleship: The highest priority of The Association of the Churches of God in Oregon and Southwest Washington is to be and to make committed followers of Jesus Christ.
- Leadership: A significant and supporting priority of The Association of the Churches of God in Oregon and Southwest Washington is to establish an environment that recognizes people with leadership potential and comes alongside to nurture and develop that person.
- Relationship: A significant and supporting priority of The Association of the Churches of God in Oregon and Southwest Washington is to be an Association that is connected by more than just a name or a structure. We desire that our actions and interactions be instigated through intentional covenantal relationships.

My role as District Pastor is to make sure these guiding principles are being fulfilled and to give support to our pastors and churches. I have sought to do that to the best of my ability during the past year.

In response to the COVID-19 crisis and to help keep our pastors connected and sharing life together, I began hosting a “pastor’s gathering” via ZOOM twice a month. We continue to meet on the First and Third Thursdays of each month at 10:00am. These one-hour sessions have been rich times to check in with each other, share best practices and pray together. As pastors and church leaders we need each other, and this has been a great way to share life together.

I am currently leading a cohort of seven pastors and church leaders from our district in weekly coaching calls. Paula Wilson is also leading a cohort of seven pastors and church leaders from our district. We are going through year one of the Gravity Leadership Academy. The Gravity Leadership Academy is a 10-month intensive coaching process that prepares leaders to disciple others in the way of Jesus. If you are interested in being part of a cohort, contact me and I will get you information on how you can join a cohort.

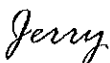
I am continuing to work with a group of regional pastors and our national office on a pilot project known as the Pacific Coast Collective. I continue also to represent our Association on several boards and committees including Warner Pacific University, Servant Solutions, Camp White Branch Board, District Council, the Credentials Board, Willamette Valley Camp Meeting planning board, as well as coaching for Leadership Focus.

As of the writing of this report there are three churches (Gales Creek, Husum Community-WA, Valley Hope Community-Hillsboro) who are in transition and/or seeking pastoral leadership. Please be in prayer for these churches as they seek God’s wisdom for their future.

The Association has been privileged to supply another grant for ongoing ministry through the Holladay Park Donor Advised Fund. The Grant went to Valley Hope to provide resources to hire a ministerial intern who would work alongside Robin to further the impact in their church and community. If you have a ministry idea or project that needs some funds, we encourage you to apply for a Grant. Please contact me if you have any questions. We also have scholarships available to Church of God students wanting to go to college or who need assistance to participate in a mission locally or abroad. This scholarship fund was established by the Holladay Park Legacy team. If you know of a deserving student, contact our office.

It has been a pleasure working with Paula Wilson this year. Paula has a pastor’s heart and a love for the pastors and churches in our Association. I am sure you have experienced this if you have reached out to our office recently. As always, Paula and I are here to serve you and to help in any way we can.

It has been another challenging year of transition, but through it all God has been present and at work in our midst. I am excited about the possibilities ahead for our Association as we move into a new reality, and I am honored to serve you as your District Pastor.

DISTRICT COUNCIL CHAIR

² Dear brothers and sisters,^[a] when troubles of any kind come your way, consider it an opportunity for great joy. ³ For you know that when your faith is tested, your endurance has a chance to grow. ⁴ So let it grow, for when your endurance is fully developed, you will be perfect and complete, needing nothing. ⁵ If you need wisdom, ask our generous God, and he will give it to you. He will not rebuke you for asking. James 1:2-5 (NLT)

How often have these verses encouraged me during these past 2 ½ years as we have gone through pandemic and social upheavals. Troubles have come our way, and yet the church has seen (or at least should have seen) it as an opportunity not only for great joy, but for increased ministry in our communities, country, and global community. If I reflect on these verses, I can see that God is still on the throne, still in ultimate control, still has the future in His hands, and is blessing us with opportunities to both mature and minister. What I have not done as often or persistently as I could have is ask Him for His wisdom and guidance. But when I have, He has graciously given it. And I have seen that to be true for our District - our Association of Churches of God here in Oregon/SW Washington - as well. THANK YOU, LORD!

My report this year will highlight some of the challenges, changes, and issues we have faced and are facing.

First, a report on our finances. Our finances have been stable this year. I have appreciated the support from our individual congregations and donors that have helped us with our ministries. These contributions and support have been valuable in meeting our budget needs. Monies from the lease of our District Office in Salem, and from the Holladay Park Fund have also made a significant impact on keeping us in the black financially this year. A big THANK YOU to you all for your love, prayers, encouragement and financial support.

In September, our District Pastor Jerry Davisson, requested a change in his role. He had felt God calling him to resume pastoral ministry and wanted to accept a call from the Rockwood Church of God congregation to a part-time pastor's position there. Jerry requested that the District consider reducing his time with the Association to a part-time position as District Pastor so that he might do both positions. After prayer and discussion, the District Council agreed to this proposal, and on Oct. 1, 2021 Jerry began his dual roles as part-time District Pastor and part-time pastor at Rockwood Church of God.

So far, the Council is ok with how that is working, but knows it is still conditional upon our desire to find and fill the remaining part-time position in our District pastoral role that is now open and available. A search committee to fill that position was formed, but it soon became apparent that before that search committee moved ahead, a potential proposal from the Pacific Coast Collective (PCC) of District pastors (all of the district pastors on the west coast, Alaska, Washington [PNA], Oregon/SW Washington, Northern California/Northern Nevada/Hawaii, Central California, Southern California/Southern Nevada, along with the Interstate Association, Hispanic Concilio, and the Church of God Ministries in Anderson, IN) would need to be taken into consideration. Our District Pastor (Jerry D.) along with three representatives from our District (myself, Teresa Hellstrom, and Fred Douglas) met twice with similar representation from the other

districts/entities mentioned above, once in Portland, OR, and once in Sacramento, CA (both 2-day gatherings) to discuss the possibilities of a cooperative partnership among the PCC in combining resources/personnel, etc., in order to increase our resources/personnel and therefore our collective ministry. This seemed to be a particularly timely discussion since four of those districts were seeing a transition taking place in their District pastor leadership during this year (including ours as Jerry was reducing to part-time).

Our District Council was given as much information as was available to consider if we would like to participate in this possibility. The Council agreed to continue investigating that possibility, and to commit resources from our budget to this potential partnership if it became a reality that we found acceptable (and beneficial) to us.

One other major challenge this year has been Camp White Branch (CWB). The CWB board accepted the recommendation from the CWB task force to prioritize the hiring of two full time positions, an Operations Manager and a Maintenance Specialist. Efforts are being made to move forward with filling these positions, which are critical for the camp to be open and serving campers this summer and beyond. In addition, the CWB Board and District Council have been dealing with the reality of insurance companies no longer wanting to cover property at camps due to the recent wildfires and climate changes. (see CWB report). Your prayers and ongoing support for CWB have been deeply appreciated and I encourage you to continue both of those! We are excited for the upcoming camping season! I also want to express a word of deep appreciation to Lisa Switzer (CWB board chair) and Durwood Ranton (CWB board member) who have sacrificially committed much time, energy, and resources to keeping our camp operational during this transitional year. Others have been very helpful, but these two have been the backbone of our volunteers keeping CWB afloat. THANK YOU, LISA AND DURWOOD!!

Other highlights:

The Council provided funds for a young(er) pastor's retreat, which provided an opportunity for those ministers in our district 40 years and younger to get together for mutual support and encouragement. Those attending felt it was very beneficial.

The Council also approved funds to help our CWB summer camp directors be able to have monies for camp programming expenses, since the camp fees do not currently provide enough for this.

The Willamette Valley Camp meeting, organized by the Region 3 churches, has seen growth and positive response each year. The goal is to keep it simple, with emphasis upon God-inspired preaching and quality family and fellowship times. Though organized by region 3, it is open to all in the district. ALL ARE WELCOME!

The scholarship fund from Holladay Park monies enabled two youth to go on a mission's trip to Mexico. This scholarship fund is also available for those who would apply for college scholarships.

The Council approved funds to help underwrite the next Ministers and Spouses Retreat. It also approved funds to help Valley Hope Church of God in Hillsboro hire an intern pastor to work with Pastor Brooke.

A request has come in from the Hoodview Church of God in Woodburn to help with pastoral support of a new Hispanic church plant that would be part of the Hoodview church. This request was endorsed by the Council to be brought to the Assembly for approval at the annual meeting. The proposal would provide \$30,000 per year for three years if approved. This is an exciting opportunity and the first new church plant the district has seen in quite a few years.

The Council also noted the dis-association of two congregations. Mt Scott/New Hope in Portland and the Lebanon church have chosen to no longer be part of our Church of God movement or our Association. And, the congregation in Roseburg has chosen to close with a goal of having a re-start/new church plant in the future.

The Council was made aware that the previous District Youth task force is no longer active or functioning. We have begun discussions on how/what a new youth guidance committee could look like for our District. Prayers are appreciated as we move forward on this. One way to help with this in the meantime is for each congregation to send in to the district office the name(s) and contact information of those who are working with the youth in their congregation. A special thanks to Teresa Hellstrom for being the guiding force for our district youth during this time, and helping hold things together. THANK YOU, TERESA!!

Again, thank you, Lord, and thank you, my friends in the District. Together we have seen God work, and bless... and continue to call us to more! I am grateful to be part of this portion of God's Kingdom. May we remain faithful, and useful instruments in our Father's Hands!

CAMP WHITE BRANCH



God is good, all the time and working at Camp White Branch!

We were blessed in so many ways this last year and want to thank all of you. We had . . . multiple volunteer work groups and individuals support projects that needed completed, an increase in individual and church donations to support our needs (both big and small), volunteers stepping forward as directors/counselors/life guards/nurses/support staff for our Church of God camps, and your support in our search for full time staff for the camp.

Last summer, we had 220 youth in attendance at our Church of God camps. We were not sure what the numbers would be post COVID since many COG youth groups had experienced reduced attendance. We are praying our numbers are higher this year. Danette Beisley, our Camp Coordinator, and the camp directors are creating exciting programs for our youth this summer. We give thanks to each one of them for volunteering their time to lead the camps.

We received a substantial memorial donation to be used to replace the wood shake roofs with metal roofing on the dining hall, Fir cabin, and the main house. This was completed this Spring by McKenzie Roofing, post all the snow. These buildings will now have more longevity and increased fire resistance. We still have 5 cabins, the office, and the staff house remaining. We need additional funds to finish, but we have started! Thanks to the volunteers and staff who worked on repairs to support the roofing project, as well as the cleanup.

We also received a grant for a double convection oven for the kitchen last year. It finally arrived and now we are working with the HVAC vendor to set up installation and proper venting. We hope to get this installed by Fall. This will really help with the cooking during camps.

We have started looking at footprints, funding requirements, and potential grant opportunities for a new bath house. This is the next building we have targeted for replacement due to leaks and other issues. We also see the need to increase the number of showers and our ADA accessibility.

Over the last year we also identified the need for a vehicle shed up by the shop. We are reviewing funding requirements and grants for this project as well over the next year.

In November, we posted on 6-8 different platforms for full time positions, a Maintenance Specialist and Operations Manager for the camp based on approval of the Board and CWB Task Force recommendation. The hiring of these positions ensures the camp is able to operate effectively, which is exciting.

Thanks again to Durwood Ranton, from Albany Church of God, for all the time he has spent at the camp making it a better place for all who go there and hosting the different groups when we didn't have staff on site.

We are ready for the camp season and ask for your continued prayers. May God use this place to reach the hearts of those who come here.

In 2022 Christian Women Connection will celebrate 90 years as a women's ministry organization. Our national theme for this year is ENCOURAGE LIFE!

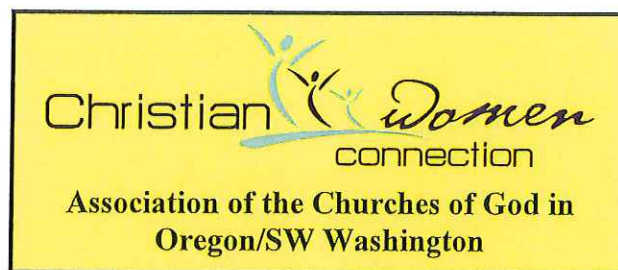

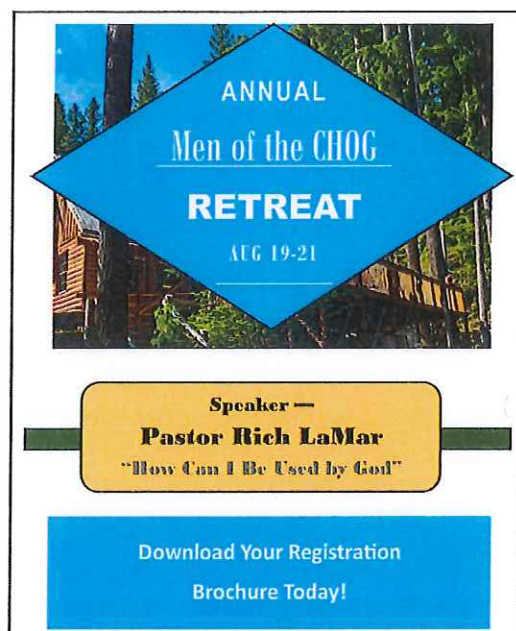
Last year we had 9 men who attended our retreat and hearts overflowed from God. Thank you Pastor Larry Wilson for sharing with us.

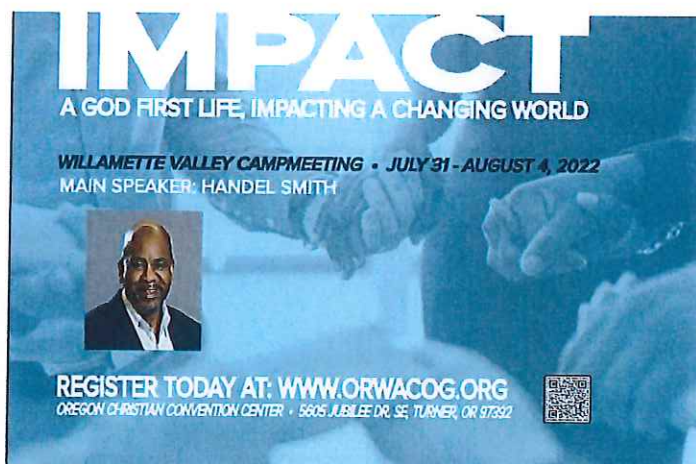

Every Jesus follower can make an impact on his or her world and those around them. That is the challenge that Handel Smith will focus on at this year's Willamette Valley Campmeeting. This annual meeting is a district-wide event for the whole family.

We invite you to be part of this annual week of worship, inspiration, and fellowship. Held on the historic grounds of the Oregon Christian Convention in Turner, Oregon, campmeeting is a great time to get away and get refreshed! Join us this year! Go to our district website to register as the registration portal is new and improved! Both day commuters and overnight guests are asked to register @ orwacog.org.



Handel Smith, Director of U.S. and Canada Strategy for Church of God Ministries, is our main speaker. His wife, **Victoria Smith**, will lead the worship. **Bruce Silver**, **Jenny Elliot** and **Mark Fast** will speak during the morning services. **David Shrout** will lead the daily morning devotion time.

A **youth program** is a key part of this week. Many youth groups camp out together and the week features daily youth worship times and other events. Youth registration is only \$75 per person and includes lodging, programming, and food. A morning **Children's Program** is held each day. For the evening service, activity bags are available.

A variety of **recreation** opportunities are also featured, including group games, evening game time after the services, and a Cornhole tournament. A small creek is available that is great for tubing down the river on a hot day!

Affordable **overnight lodging options**, including cabins, RV spaces and campsites, are available with a cost per person of only \$13 per night (age 5 and above), with a \$50 family maximum per night. **Commuters** are also welcome (\$5/day). **Meals** are also available onsite on a donation basis, but registration is required (meal cut-off is July 24).

Some of our guiding philosophy is to be less structured and more relational, to be volunteer-led, and to be donation-based. The overnight fee as well as the day fee we charge are really suggestions and only cover what we are charged by the host site. Food and programming costs (including guest leaders) are extra and are dependent on donations and offerings. The WVC checking account balance on June 12, 2022, was \$30,891.32. This year's event has a budget of \$14,575 with fees, donations and offerings as our only source of income.

Our thanks to the volunteers who make this week happen, including planning, set-up, worship, speakers, sound techs, children's ministry, cooking, and clean-up. We could not do this week without you!
