

#### ANNUAL BUSINESS MEETING July 20, 2019

Pastor Jerry Davisson welcomed the group and led in prayer. Doug Beisley led us in a short time of worship. Pastors Jon Nutter, Denise Douglas, Rich LaMar and Steve Kufeldt shared about what their churches are doing in community outreach.

**CALL TO ORDER:** The meeting was called to order at 10:54 a.m. by acting Chair Glen Hossler.

#### **SEATING OF DELEGATES:**

Ministers: 49 Lay Delegates: 36 Zoom delegates: 1

Total: 86

**APPOINTMENT OF TELLERS:** Jeff Foster, Milt Culver, Gary Johnson and Cecil Baird were appointed as tellers.

**APPROVAL OF MINUTES FROM JULY 21, 2018:** Gregg Hicks, Julie Jackson moved and seconded to approve the minutes from July 21, 2018. Motion carried.

#### **UPDATES AND REPORTS:**

**Acting Chair report:** Glen publicly thanked past Chair Jackie Scott for her leadership as council chair.

He also said supports the council's decision to not support Warner Pacific University in the budget but encouraged congregations and individuals to support the college.

He thanked Mel Neu for his many years as Camp White Branch board chair and all he has done for the camp. The group gave him a standing ovation.

**Camp White Branch Chair:** New chair Lisa Switzer shared her vision for the camp. The dedication of the new multipurpose building will be Oct. 19 from 10 am - 2 pm. Danette Beisley has accepted the role of Church of God Camp Coordination, working with Lindsey Speer from Reedsport. A new young adult retreat is being planned for the fall. John Kuykendall was recognized for his 50 years of service as a camp director.

**Warner Pacific University:** Andrea Cook shared about Warner Pacific University and some of the newer programs and studies the university has launched.

**District Pastor's report:** District Pastor Jerry Davisson shared from his report. He mentioned that the district is part of a pilot project that supported by regional pastors and our national office called the Pacific Coast Collective, which is churches of God across the West

Coast seeking to develop ways they can work together across state lines to see the Kingdom of God advance. He shared about the monies that the District will receive from the sale of the Holladay Park church. In November the district will host a Gravity Leadership Bootcamp, which is a series of four one-day training events to help equip leaders to lead like Jesus.

**Treasurer's report:** District Treasurer Steve Robertson presented the budget and Lorin Myers/Jackie Scott moved to accept the budget as presented.

**Ballot:** The ballot included ratification of Glen Hossler as Association Chair, Mel Neu as Camp White Branch Board member, and ratification of the budget.

Results of the ballot: All items passed. The official ballot results are in the district office.

Thank you to Oak Park Church of God for hosting our meeting.

Meeting adjourned at 12:15 pm with Pastor Greg Hicks leading in prayer.

#### Rev. Jerry Davisson, DMin | DISTRICT PASTOR

To say these are strange and unprecedented times is perhaps an understatement. With the onset of COVID-19 requiring the discontinuation of in-person church services we have all had to adapt to a new rhythm of life. We are also experiencing racial and political tension in our country, causing much division among even people of faith. It is more important then ever to hear the words of John as he said in 1 John 4:7-16:

<sup>7</sup> Dear friends, let us love one another, for love comes from God. Everyone who loves has been born of God and knows God. <sup>8</sup> Whoever does not love does not know God, because God is love. <sup>9</sup> This is how God showed his love among us: He sent his one and only Son into the world that we might live through him. <sup>10</sup> This is love: not that we loved God, but that he loved us and sent his Son as an atoning sacrifice for our sins. <sup>11</sup> Dear friends, since God so loved us, we also ought to love one another. <sup>12</sup> No one has ever seen God; but if we love one another, God lives in us and his love is made complete in us.

<sup>13</sup> This is how we know that we live in him and he in us: He has given us of his Spirit. <sup>14</sup> And we have seen and testify that the Father has sent his Son to be the Savior of the world. <sup>15</sup> If anyone acknowledges that Jesus is the Son of God, God lives in them and they in God. <sup>16</sup> And so we know and rely on the love God has for us.

God is love. Whoever lives in love lives in God, and God in them.

As District Pastor, I am striving to live this out in my daily life and as I interact with the pastors and churches of the association.

As we continue to navigate these uncharted waters let me remind you of the role of the district. According to our guiding principles:

The District exists to a) assist the local Churches of God in Oregon and Southwest Washington discern and achieve their individual missions, and b) partner with them to minister together in ways that they cannot minister separately. The three priorities the association has adopted are as follows:

- **DISCIPLESHIP:** The highest priority of The Association of the Churches of God in Oregon and Southwest Washington is to be and to make committed followers of Jesus Christ.
- **LEADERSHIP:** A significant and supporting priority of The Association of the Churches of God in Oregon and Southwest Washington is to establish an environment that recognizes people with leadership potential and comes along side to nurture and develop that person.
- RELATIONSHIP: A significant and supporting priority of The Association of the Churches of
  God in Oregon and Southwest Washington is to be an Association that is connected by more
  than just a name or a structure. We desire that our actions and interactions be instigated
  through intentional covenantal relationships.

My role as District Pastor is to give vision to our association and support to our pastors and churches in these changing times. This year was a year of learning and adding tools to my tool belt so I can better fulfill that role.

In January I completed a Missional Coaching internship with Dr. Bob Whitesel. The purpose of this internship was to better prepare myself to help the churches in our association live out our missional calling. Dr. Whitesel has written 13 books and has over 20 years of church consulting experience. I have learned a great deal from Dr. Whitesel and I am available to use what I have learned to help your church.

In June I completed my Doctor of Ministry degree at Fuller Theological Seminary. As part of my final project I have written a *Missional Coaching Handbook* that pastors and leaders can use to help coach their people out into their own neighborhood. I am making some tweaks to the handbook to make it more user friendly. The handbook is available to you and I am available to help teach and lead your congregation to live out your missional calling and to better equip your leaders to engage their neighborhood with the gospel.

I also completed training with Gravity Leadership and am one of their certified coaches. I am currently leading a cohort of seven pastors from our district, in weekly coaching calls, to learn to center our lives and leadership in the love of Jesus. This Gravity Leadership Academy is a 10-month intensive coaching process that will prepare you to disciple others in the way of Jesus. If you are interested in being part of a cohort contact me and I will get you information on how to apply.

In response to the COVID-19 crisis and to help keep our pastors and staff connected and sharing life together I began hosting a "pastors gathering" via ZOOM every two weeks. These meetings began in April and are continuing. These one-hour sessions have been rich times to check in with each other, share best practices and pray together. This will be something that I will continue even after the pandemic is over. As pastors and church leaders we need each other and this has been a great way to share life together, even if it is virtually.

I am continuing to work with a group of regional pastors and our national office on a pilot project known as the Pacific Coast Collective. The collective has been instrumental in developing a training program called the Chapter 4 Institute. Rooted in the significance of Luke 4:16-21, the Chapter 4 Institute is an immersive, cohort-based leadership experience that creates passion for spiritual and social renewal in communities. Through experience-based learning, the Chapter 4 Institute challenges leaders to reimagine how the church might earn its place as an essential player in solving community issues. Currently we have four churches and nine participants who are part of the initial C4 program. Look for details to come.

I continue to represent our association on several boards and committees including Warner Pacific University, Servant Solutions, the Regional Pastors executive committee as well as the Camp White Branch Board, District Council, the Credentials Board, and the Willamette Valley Camp Meeting planning board.

As member of the Board of Trustees at Warner Pacific University I am excited to welcome Dr. Brian Johnson as the 8<sup>th</sup> president of the University. Dr. Johnson brings a deep spirituality and a wealth of experience in making higher education available to minority students. I look forward to having an opportunity to introduce Dr. Johnson to the pastors of our association and to renew our support and commitment to the ongoing mission of WPU.

The leadership of Camp White Branch was asked to commission a Strategic Planning Task Force to look at how we can make the camp and her ministry a benefit not only to the association but to the wider church and the Kingdom of God. You can see the details of that work in the Camp White Branch report. I want to thank Leonard and Stacey Meyer for their tireless work with the camp. Well done! I also want to thank Lisa Switzer and the army of volunteers who continue to work on improving the camp and its facilities. We look forward to the camp providing a space to introduce people to Jesus and to grow the Kingdom of God.

As of the writing of this report, there are no churches who are actively seeking pastoral leadership. New pastors in the last fiscal year for our association include Andrew Loyd (Cottage Grove) and Doug Balzer (Newberg). We welcome Matt Ingalls (Salem) back to Oregon. I would encourage you to get to know these new pastors and make them feel welcome.

As part of the association's ongoing mission to make disciples and grow leaders, we have partnered with Gravity Leadership to host a series of four one day bootcamps to help equip leaders to lead like Jesus. We have completed two of the four. However, due to COVID-19 we have had to postpone the other two. We are planning to have our third bootcamp on August 22<sup>nd</sup>, COVID permitting.

The District Council has made the decision to lease out the Salem office to help balance the association's budget. We are working on the details of how a virtual office will work. Our goal is to continue to provide the services you have come to expect in a seamless way. We will keep you informed if there are any changes to mailing address or phone number. If you have any questions, please don't hesitate to ask.

Finally, due to the changes coming for the office, both Val and Sally have prayerfully come to the conclusion that their time of serving the association will come to a close at the end of August. It has been an absolute joy to work with these two dedicated women. They have served the association well for many years and it is hard to see them go. I wish them well in the new adventure God has for them both. I will be sharing a job posting soon to find a person or persons to help fill the needs of the association moving forward. Please take the time to thank Val and Sally for their years of service to the district.

It has been a challenging year but through it all God has been present and at work in our midst. I am excited about the possibilities ahead for our association and I am honored to serve you as your District Pastor.

#### DISTRICT COUNCIL CHAIR.

As I sit at my computer, mulling over this Annual Report, I am struck by the differences from last year to this. Last year I was the interim Chair, trying to figure out how to navigate conducting the Annual Business Meeting. This year, I am no longer the interim, but am trying to figure out how to navigate conducting the Annual Business Meeting virtually (via ZOOM). What a difference the coronavirus pandemic has made... in our lives, in our churches, in our ministries, in our camps! So much is different! And yet, there remains one great constant... our Lord and Savior! Jesus IS the same today as He was yesterday, and will be tomorrow! How comforting to know that He is still in control! That He knows what the future holds! That He is the One, in fact, holding the future! I can worry about how much things are different, or I can rest in the Presence of the One who holds it all in His hands!

And so... as we look toward having our annual meeting virtually this year, I know there will be glitches. I know there will be frustrations. I know it won't be how we'd like it to be. But I also know that we will look to the One we serve, and seek His face, and His grace, and His guidance, and ask His blessing upon our endeavors to serve Him well as He leads through this time. I thank you all for your patience and grace as we do our best with not only this meeting, but with our ministries to Jesus!

We (sadly) say goodbye to our Office administrators, Sally Ranton and Valerie Borst, both of whom are stepping down from their positions at the end of August. They have served the district so well for many years; and all of our ministries have been blessed by their wonderful, dedicated ministry and service. We pray for God's richest blessings upon them both as they transition to new ministries and focuses in their lives. **THANK YOU SALLY AND VALERIE!!** 

You will hear reports on some of the things I will just briefly touch on here. CWB Task Force has done an excellent job laying a foundation for next steps that will move CWB toward being a viable revenue producing camp that offers the opportunities for spiritual growth and impact we want it to be and know it can be. That task force will continue to serve the CWB Board under the guidance of the District Council.

Speaking of CWB, all summer camps and fall retreats were cancelled due to the Covid-19 restrictions. Those restrictions also caused the cancellation of the Willamette Valley Camp Meeting, and the gathering in person of many of our regional groups and all of our churches for a while. It also postponed the third gathering of those who are involved with the Gravity Leadership workshops. And even though it caused changes to be made, we are excited about the C4 program some in our district will be taking advantage of.

Because of the cancelations of so many of our camps and events this summer, our District and CWB Board applied for government PPP funds (loans), and are grateful to be able to help our employees through those during this pandemic. We also were able to help some of our pastors through our Benevolence Fund this year. The Council has developed an Employee Handbook for the District, (something we have not had, and definitely need), and it has been approved and put into operation this summer. This includes CWB employees.

Knowing that we would no longer have income from the sale of the Riddle property for this next year, and that we needed to present a balanced budget, the Council approved the move to downsize our use of office space and lease our District Office building, beginning the first of September. That income will enable us to not make any budget cuts in personnel or current ministries. District Pastor Jerry Davisson will share more in his report about how the District Office will look as we move ahead. Your prayers are appreciated for this transition.

As we continue to navigate how to serve Jesus and do ministry during the coronavirus pandemic and racial tensions facing our country, I have been impressed with this thought; that God has placed US here, in our communities and spheres of influence, for SUCH A TIME AS THIS! As Esther sought God through prayer, and then boldly took action for the sake of her people, may we, too, intentionally and fervently seek God, and then boldly act for the good of those in whose midst God has place us!

We had a great 2019 camp season last summer. The Neu multipurpose building was utilized for worship, games, evening events, and when it was raining or cooler outside. We want to continue to thank all who supported the completion of this building.

In October, we officially dedicated the "Neu" multi-purpose building, named in honor of Mel and Marvin Neu, who spent countless hours at the camp. We had close to 125 people in attendance on a very rainy day. Many in attendance shared stories of their time at camp and the impact it had on their lives or their children's.

Our updated website went live in February this year with a new look, as well as a new online camp registration system. You can also find information on the needs of the camp and upcoming events. In May, the Board made the decision to cancel 2020 summer camps due to COVID19. This was a difficult decision for us. Post our decision, the Governor declared overnight camps were not allowed to operate. This will impact our operating funds for the next year. We have been blessed with donations for some needed repairs and maintenance and believe God will provide. Groups and individuals with specific skills are encouraged to assist with projects at the camp, you can contact us at volunteer@campwhitebranch.org. We update our need list items and projects requiring specific skills sets on our website under the volunteer tab.

Post our decision to cancel, Lindsey Speer, Youth Leader at Reedsport COG, stepped up to organize a virtual summer camp for middle and high school aged youth. She created a program that could be utilized by other church's or faith based groups, not only our COG youth leaders. We were excited to have something to offer our youth.

Danette Beisley, Camp Coordinator, worked on assessing our camp prices, online registration process, and guidelines for Directors/Counselors. We increased prices to ensure Directors have funds for programming (activities, speakers, band, crafts, etc.) to make our camps the best possible. We are excited to report that Jon Nutter, has volunteered to be the Young Adult Camp Director and Doug and Danette Beisley will be shifting to direct Jr Camp. We are in need of a Middle School Camp Director. Please pray this position be filled soon and if you are interested please contact Danette.

Last year the District Council appointed a task force (Glen Hossler, Jerry Davisson, Mike Kernutt, Lisa Switzer, Alan Chaney, Lindsey Speer) to define the vision, mission, purpose and values for the camp. This group has met multiple times, conducted interviews, reviewed past task force information and details of other camps in the area, visited the camp, and much more to inform this work. Clearly defining this and gaining District support of the direction desired for this youth ministry is important. This work was completed, presented, and approved by the CWB Board and District Council. The task force has asked to continue as a group to define the strategy and plans to move this work forward. Thanks to this group for their support!

#### WILLAMETTE VALLEY CAMPMEETING TASK FORCE

"Fully Alive" is the call of Jesus to every believer and was to have been the theme for this year's Willamette Valley Campmeeting (WVC). While we reluctantly made the decision to cancel this year's event, we look forward to next summer (August 1-5, 2021) when the same theme and scheduled speakers will be part of this annual week of worship, inspiration, and fellowship. Held on



the historic grounds of the Oregon Christian Convention in Turner, Oregon, this annual week is a great time to get away and get refreshed! Make plans now to join us next year.

Marshall Snider will be our guest speaker next year at all main sessions as well as the daily morning youth service. Marshall is the founder of "Because People Matter," an organization that brings key community influencers and change makers together in a movement that has transformed thousands of people. He also partners with several Portland-area churches in the area of leadership development.

Daniel Ryan, Overseer of Music Ministries at Lynchwood Church of God in Portland, will lead worship at the main sessions next year.

A **youth program** is a key part of this week. Many youth groups camp out together and the week features daily youth worship times and other events. Youth registration is projected to be only \$75 per person and includes lodging, programming, and food. Some **children's programming** is planned and a variety of **recreation** opportunities are featured, including a small creek that is great for tubing down the river on a hot day!

Affordable **overnight lodging options**, including cabins, RV spaces and campsites, are available onsite with a projected cost per person of only \$13 per night (age 5 and above), with a \$50 family maximum per night. **Commuters** are also welcome. **Meals** are available onsite on a donation basis.

While this annual week was originally started as a cooperative event by Region 3 churches (Albany, Salem and Woodburn), it has now grown to a district-wide event. Last year 20 district congregations were represented with approximately 200 people attending during the week.

Some of the core values of this week are to be less structured and more relational, to be volunteer-led, and to be donation-based. Our thanks to the volunteers who make this week happen, including planning, set-up, worship, speaking, children's ministry, cooking, and clean-up. We could not do this week without you!

On the financial side, last year's campmeeting received \$3,541.21 less than we spent, but thanks to a generous \$25,000 donation from Holladay Park Church of God (received in January 2019), the current balance of the WVC checking account is \$30,707.05.
