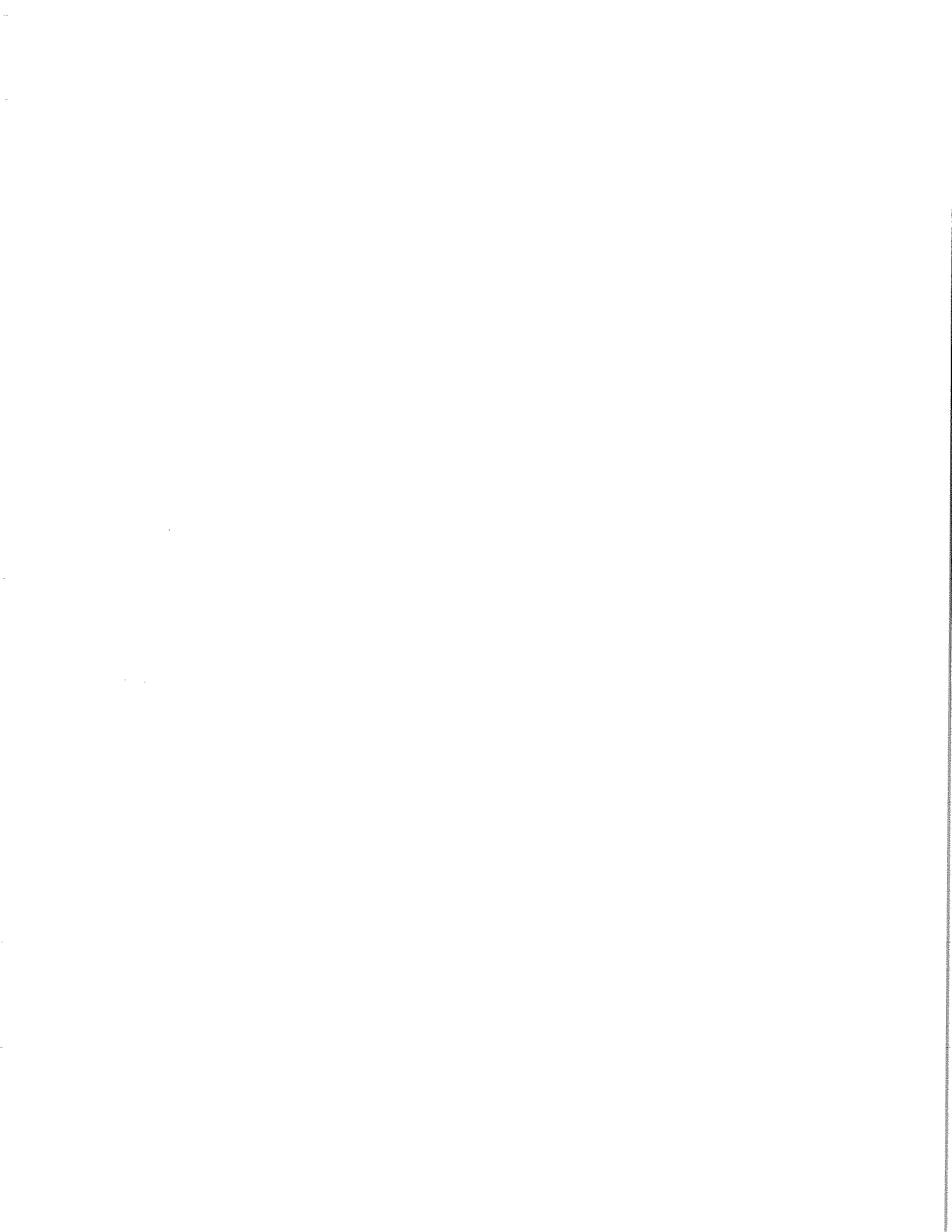

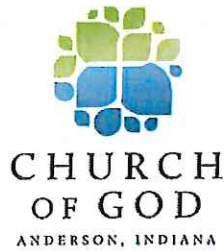

**ANNUAL BUSINESS MEETING
August 1, 2020**

Pastor Jerry Davisson welcomed the group and led in prayer.

CALL TO ORDER: The meeting was held via ZOOM in a Webinar format and Chair Glen Hossler called the meeting to order at 10:03 a.m., and led in prayer. He gave information on how to use the chat room for registering and also how to vote. Most reports will not be shared orally.

SEATING OF DELEGATES:

Ministers: 39

Lay Delegates: 19

Council member: 1

Total: 59

The motion by the chair to accept the voters passed unanimously.

APPROVAL OF MINUTES FROM JULY 20, 2019: Denise Douglas moved and Jon Nutter seconded to approve the minutes from July 20, 2019. Motion carried.

UPDATES AND REPORTS:

All the reports are part of the annual booklet. The following is a highlight of a few of these reports.

Chair report: Chair Glen Hossler shared portions of his report, noting that the council has decided to close the district office site to help with budgeting. The building will be leased for three years, not sold, which will give the option to return if things do not work out. After prayerful consideration, office personnel Sally Ranton and Valerie Borst have both given their resignation, effective August 31.

District Pastor Report: Jerry Davisson has been extremely impressed by the way pastors and churches have risen to the technological challenges forced on them during this coronavirus time. He has been with the district now for three years and emphasized that he is here to serve our churches. On June 12 he finished up his doctoral studies. His goal is to make the closing of the district office site as seamlessly as possible. Steve Robertson will take on, in an interim position, the job of financial secretary. We will be looking to outsource the financial part of the association. A job description has been sent out, looking for a new office assistant. A benefit of the COVID restrictions is that Jerry has been having virtual meetings once every two weeks with pastors. He plans to continue doing this as it has been very beneficial for all.

Camp White Branch Report: Lisa Switzer gave her report. There were over 300 campers for 2019 and they had the first young adult camp last year. The new multi-purpose building was used for the first time last summer. This building was dedicated in October with 120 people attending. The web site has also been updated. Because of COVID restrictions, the difficult decision was made to not have camps this year. A virtual youth camp was held the last of July. CWB is needing some camp directors for 2021.

Warner Pacific University: July 31 was Dr. Andrea Cook's last day as president of the university. Several events, in keeping with social restrictions, were held and concluded with a drive-thru parade on July 31 and Dr. Brian Johnson has taken over the reins as 8th president of WPU. Shannon Johnson, vice president of institutional advancement and external relations, shared happenings at WPU in lieu of Dr. Brian Johnson. Chair Glen gave a personal word of thanks to Dr. Cook and welcomed Dr. Brian Johnson.

Financial Report: Steve Robertson gave the financial report, which is part of the booklet.

Ballot Vote: The Association Budget, and two positions on the Camp White Branch Board, Lisa Switzer and Owen Hinkle, were all ratified.

Chapter 4 Initiative Report: Jon Nutter is a participant in the Chapter 4 Institute (C-4), which is part of the Pacific Coast Collective. This Collective includes Washington, Oregon, California and our national offices. He explained that the C-4 is a cohort-based leadership experience that creates passion for spiritual and social renewal in communities. It challenges leaders to re-imagine how the church might better move out into the community, addressing social and community issues. Nine of the 40 participants are from Oregon.

Linda Tucker-Bays shared what the Scappoose church has been doing since the COVID-19 restrictions. This involved making baskets for the high school seniors, with individuals or families adopting a senior. This idea has been extremely successful and she plans to continue this project this coming year.

A video from Dave Shroul thanking Sally Ranton and Valerie Borst for all their work in the district office will be posted to the web site. Dave hired both Sally and Val and was representing the district ministers. Julie Jackson, representing the congregations, also expressed thanks to the women. Thank you Sally and Valerie! Many delegates posted on the chat venue, thanking them. Chair Glen also gave thanks to them, said there will be a gift for each of them and then offered a prayer of thanks and blessing for the two.

District Pastor Jerry Davisson adjourned the meeting with prayer at 11:50 a.m.

DISTRICT PASTOR

As I sit down to write this report the Governor of Oregon has just lifted most of the Covid-19 restrictions that have been in place since the beginning of the pandemic. This is welcome news for many pastors and churches who have had to pivot their ministries online or taken a hybrid approach to gathering. Even as we get back to “normal” there is still an undercurrent of racial and political tension in our country that is causing division among people, even brothers and sisters in Christ. The pandemic has revealed much about the church and the world we occupy. Many of our churches are rethinking their approach to ministry and to what the future holds for them. We all continue to seek God’s Kingdom come to our community as it is in heaven. The truth is, we cannot simply go back to the way we have done ministry in the past. Our world has changed too dramatically. We need to work together to rethink our mission in light of a changing world.

I would like to remind you of the role of the District Office as we seek to serve our churches during these challenging times. According to our guiding principles:

The district exists to a) assist the local Churches of God in Oregon and Southwest Washington discern and achieve their individual missions, and b) partner with them to minister together in ways that they cannot minister separately. The three priorities the association has adopted are as follows:

- Discipleship: The highest priority of The Association of the Churches of God in Oregon and Southwest Washington is to be disciples and to make committed followers of Jesus Christ.
- Leadership: A significant and supporting priority of The Association of the Churches of God in Oregon and Southwest Washington is to establish an environment that recognizes people with leadership potential and comes alongside to nurture and develop that person.
- Relationship: A significant and supporting priority of The Association of the Churches of God in Oregon and Southwest Washington is to be an Association that is connected by more than just a name or a structure. We desire that our actions and interactions be instigated through intentional covenantal relationships.

My role as District Pastor is to make sure these guiding principles are being fulfilled and to give support to our pastors and churches. I have sought to do that to the best of my ability during the Covid-19 pandemic.

In response to the COVID-19 crisis and to help keep our pastors connected and sharing life together, I began hosting a “pastors gathering” via ZOOM every two weeks. We are continuing to meet on the First and Third Thursdays of each month at 10:00am. These one-hour sessions have been rich times to check in with each other, share best practices, and pray together. As pastors and church leaders we need each other and this has been a great way to share life together, even if it is virtually.

I am currently leading a cohort of six pastors from our district in weekly coaching calls. We are going through year two of the Gravity Leadership Academy. The Gravity Leadership Academy is a 10-month intensive coaching process that will prepare you to disciple others in the way of Jesus. Year two is focused on learning how to apply the things learned in year one and to learn to live missionally. If you are interested in being part of a cohort, contact me, and I will get you information on how you can join a cohort. Scholarships are available for those who need it.

I am continuing to work with a group of regional pastors and our national office on a pilot project known as the Pacific Coast Collective. The collective has completed its first Chapter 4 Institute. C4 institute, as it is referred to, is rooted in the significance of Luke 4:16-21. The C4 Institute is an immersive, cohort-based leadership experience that creates passion for spiritual and social renewal in communities. Through experience-based learning, the C4 Institute challenges leaders to reimagine how the church might earn its place as an essential player in solving community issues. A video highlight will be shown at this year’s annual meeting.

I continue to represent our Association on several boards and committees including Warner Pacific University, Servant Solutions, Camp White Branch Board, District Council, the Credentials Board, Willamette

Valley Camp Meeting Planning Board, as well as coaching for Leadership Focus. Much of this work this past year has been virtual. However, I look forward to meeting with these teams face to face again soon.

This has been a year of challenge for Camp White Branch. With the COVID shutdown that halted camp operations, we lost Leonard and Stacy Meyer as our camp staff. During this transition Lisa Switzer and an army of volunteers have continued to work on improving the camp and its facilities. I want to thank all of them for all they have done and are doing to get the camp ready to provide a space to introduce people to Jesus and to grow the Kingdom of God. I would also like to thank Danette Beisley for all the work she has done to prepare for the reopening of our summer camping program. I look forward to hearing great reports of young lives changed this summer at camp.

As of the writing of this report there are 6 churches (Gales Creek, Husum Community, Maranatha, Rockwood, Hucrest, Reedsport) who are in transition and/or seeking pastoral leadership. Please be in prayer for these churches as they seek God's wisdom for their future.

As part of the association's ongoing mission to make disciples and grow leaders, we have partnered with Gravity Leadership to host a series of four one day bootcamps to help equip leaders to lead like Jesus. Before the pandemic shut down, we were able to have two of those bootcamps. We have scheduled our final two bootcamps for October 2nd, 2021, and January 29th, 2022. If you are interested in participating, please contact our office. It is not mandatory for you to have been part of the first two in order to participate in the final two.

Speaking of the office, it has been a pleasure working with Paula Wilson this year. Paula has a pastor's heart and a love for the pastors and churches in our Association. I am sure you have experienced this if you have reached out to our office recently. As always, Paula and I are here to serve you and to help in any way we can.

The Association has been privileged to supply two grants for ongoing ministry through the Holladay Park Fund. One grant went to Hannah Grace, a ministry to parents who have had to give up their children to Foster Care. Hannah Grace is a ministry started by Jason and Tara Hood who also pastor the Hill Top Community Church of God in Oregon City. The second grant went to Snoopy Land, a ministry of the Sunset Park Church of God. The grant will help them build a covered area for their Day Care. If you have need of some funds to help with a new or existing ministry, please contact the office for an application. We also have scholarships available to Church of God students wanting to go to college or who need assistance to participate in a mission locally or abroad. This scholarship fund was established by the Holladay Park Legacy team. If you know of a deserving student, contact our office.

It has been another challenging year, but through it all, God has been present and at work in our midst. I am excited about the possibilities ahead for our Association as we move into a new reality, and I am honored to serve you as your District Pastor.

DISTRICT COUNCIL CHAIR

Last year I started my annual report with thoughts that are uncannily still very appropriate for this year. I wrote: *What a difference the coronavirus pandemic has made... in our lives, in our churches, in our ministries, in our camps! So much is different! And yet, there remains one great constant... our Lord and Savior! Jesus IS the same today as He was yesterday, and will be tomorrow! How comforting to know that He is still in control! That He knows what the future holds! That He is the One, in fact, holding the future! I can worry about how much things are different, or I can rest in the Presence of the One who holds it all in His hands! ...* I also know that we will look to the One we serve, and seek His face, and His grace, and His guidance, and ask His blessing upon our endeavors to serve Him well as He leads through this time.

As you can see, not a lot has changed in this past year, although we do thank God for His Presence and grace and provision during this past year. We also thank Him for the progress we are seeing with the pandemic, for the hope we have that there will be a better day, and for the lessons we have learned that can make our ministries going forward more fruitful, timely, and engaging.

During our last annual meeting we touched on a number of transitions that we knew would be taking place in our District. Some updates: after Sally Ranton and Valerie Borst stepped down as our District Office administrators, District Pastor Jerry Davisson requested the District hire Paula Wilson as the D. O. Administrator/Manager. The District Council approved that hire, and Paula has done a wonderful job helping us make not only the transition with the office manager change, but also with the transition of moving the D. O. to its new location in the Newberg River Street Church of God building.

The Salem District Office Building has been leased per approval during last year's annual meeting and the new tenants are a home health care group – New Horizons. They are good tenants, and have upgraded the District Office building at their own expense. The income from this lease has been significant in creating the positive budget for this next year. Due to my close physical proximity, I have been acting on behalf of the Council as the property manager for this lease.

Another transition has been at **Warner Pacific University**, where the new **President, Dr. Brian Johnson**, replaces outgoing President Dr. Andrea Cook. We hope you will get a chance to meet Dr. Johnson soon.

District Pastor Jerry Davisson and the Credentials and Advisory Board will also highlight a number of transitions in our congregations and pastors this past year. Please see their reports for that information.

Jerry D. has done a zoom gathering of our district pastors during this pandemic and that twice-monthly meeting has been well received, with 15-20 pastors each call. This has been an on-going encouragement to all participants, especially during the unique challenges the pastors have faced with this pandemic.

Major transitions faced the **Camp White Branch** Board also this past year. There were no camps last summer due to the pandemic, camp managers Leonard and Stacy Meyer's left at the end of November, and there were no firefighters housed at the camp last summer. Yet, **God has blessed and provided** – see CWB Chair Lisa Switzer's report. CWB began paying back its loan to the Association, although with no significant income this past year other than the encouraging donations from congregations and individuals, this payback may need to be adjusted.

A **ministry fund** to help churches looking for financial assistance was established from a generous donation from the **Holladay Park Church of God** after the sale of their property. One church, **Faith Rock Community**,

Oregon City, received \$30,000 to help them secure a building for their **Hannah Grace non-profit ministry**, whose primary effort is working with foster care families. Churches are encouraged to apply for assistance.

During this pandemic year, I have been so encouraged with the numerous reports I have heard of how pastors and congregations have figured out how to adapt and do ministry differently, but effectively. I have also been encouraged at the faithful on-going financial support from our district churches during this challenging year and I have been so encouraged by the numerous examples of **God's faithfulness! God is good! We serve a wonderful, omnipotent Savior!**

I thank God for each of you who serve Jesus in your congregations, communities, and our district so faithfully, and pray that we truly will be a church united in purpose and ministry.

CAMP WHITE BRANCH

What a year we have had! God has taken care of our needs and blessed us with volunteers to help, donations to keep the camp bills paid, and prayers by many. Thanks so much!



As some of you may know, we were not able to open for camps or rentals in 2020 due to the Governor's COVID guidelines issued for organized camps last year. With no operational revenue coming in for a year, the camp faced financial challenges and the board had to make difficult decisions related to the operational budget. One being to let Leonard and Stacey Meyer, our caretaker and reservation managers, go since we could see our operating funds would not take us to this summer. We want to thank and recognize the love, dedication, and hard work Leonard and Stacey invested in the camp for the 6+ years they were there. They definitely left the camp better than when they arrived. The role of caretaker requires special individuals with a love for Christ, youth ministry, and a desire to live in a remote location and Leonard and Stacey were those kind of people.

Without caretakers at the camp, we have been blessed to have Durwood Ranton, from Albany COG, step forward last November to take the lead with maintenance work in the interim. Durwood has done a great job! He and a few others did frequent checks on the camp and performed work on site.

We also asked churches and individuals for support to keep the camp in operation. Thanks to so many of you, we were able to keep the camp bills paid, camp maintained, and make much needed repairs this spring in preparation for opening. We were also blessed recently with grant funds from the State of Oregon.

In April, the State provided updated guidelines for organized camps allowing us to open this summer. Camps may need to look a little different but we are able to open. What a blessing! Danette Beisley, our Camp Coordinator, has spent hours working on counselor training and defining how we will operate under COVID guidelines. She will also be the director for 3 out of 6 camps this summer. If you are able to help with this ongoing need of directors next year, please let her know. We are also still in need of volunteers this summer to operate since we do not have permanent camp managers. We have many volunteers - counselors, lifeguards, nurses, cleaning, cooks, interim maintenance lead, registration lead, and skilled labor from our churches - but still have a few open positions. If you can help, please contact us. Your support allows us to open. Please continue to pray for our summer camp ministry in session now. You are greatly appreciated!

I know board members have really enjoyed getting to meet individuals from different churches who have stepped forward when we asked for help. We look forward to further development and opportunities for individuals and churches to engage with our Church of God camp ministry on a regular basis. Whether it be renting the camp for your next retreat, family camp, or prayer summit, coming to do skilled work needed onsite, having a mission trip at camp, volunteering as camp staff, giving financial support for special projects . . . there are many opportunities to be involved. We are working on providing regular updates on our website, Facebook page, and in the Connection.

The District Council appointed Task Force (Glen Hossler, Jerry Davisson, Mike Kernutt, Lisa Switzer, Danette Beisley, tbd) and the CWB board will be focused on determining when and how camp operations will work going forward. We still do not have funds to hire permanent staff and will wait to see how this summer goes.

I feel God places challenges in our way to make us stronger. We have needed to be patient and wait on His timing to provide what we need. We will continue to do this. Thanks for your prayers for wisdom and guidance.

We continue to be part of Leadership Focus, a national Church of God system that is working well for many with the Church of God nationally. The fiscal year for CWC runs April 1 through March 31st. Deposits made 7/4/2020 – 6/30/2021 totaled \$13,160.80. Expenses were \$4396. Christ Birthday Offering through CWC Oregon was \$9,127.86 and CBO sent directly from churches to National was \$3,816.37. Oregon churches gave a total of \$13,444.17. Sixteen churches out of 42 Oregon congregations gave to CBO.

A special thank you to Lynchwood Church of God for hosting our Spring Connection on March 19 – 20th. Jenny Dunbar Mihsill, missionary to Cote d'Ivoire was our guest speaker. She spoke on 'Empower Life' based on 2 Corinthians 4:7. Jackie Scott and Sally Kuykendall lead in music worship. About 45 ladies from Oregon congregations attended. Our silent auction helped raise \$1000 for the WPU scholarship.

Our national Executive Director, Dr. Arnetta McNeese Bailey, has authored a book, It's not In Vain. She has served CWC since 2002. She will be recognized in our national board/council meeting in October.

WILLAMETTE VALLEY CAMPMEETING TASK FORCE

"Fully Alive" is the call of Jesus to every believer. We are excited that the Willamette Valley Campmeeting returns this year after being cancelled last year due to the pandemic. The same theme, main speaker, and worship leader scheduled for last summer will lead us this year on the theme of being "Fully Alive!" We invite you to be part of this annual week of worship, inspiration, and fellowship. Held on the historic grounds of the Oregon Christian Convention Center in Turner, Oregon, campmeeting is a great time to get away and get refreshed! Make plans now to join us!



Marshall Snider will be our guest speaker at all main sessions as well as the daily morning youth service. Marshall is the founder of "Because People Matter," an organization that brings key community influencers and change makers together in a movement that has transformed thousands of people. He also partners with several Portland-area churches in the area of leadership development. **Daniel Ryan**, overseer of Music Ministries at Lynchwood Church of God in Portland, will lead worship.

A **youth program** is a key part of this week. Many youth groups camp out together and the week features daily youth worship times and other events. Youth registration is only \$75 per person and includes lodging, programming, and food. Some **children's programming** is planned and a variety of **recreation** opportunities are featured, including a small creek that is great for tubing down the river on a hot day!

Affordable **overnight lodging options**, including cabins, RV spaces and campsites, are available with a cost per person of only \$13 per night (age 4 and above), with a \$50 family maximum per night. **Commuters** are also welcome (we are being charged a new fee of \$5/day for commuters). **Meals** are also available onsite on a donation basis. Registration is currently open @ www.orwacog.org.

While this annual week was originally started as a cooperative event by Region 3 churches (Albany, Salem and Woodburn), it has now grown to a District-wide event. Two years ago we had 20 district congregations represented with approximately 200 different people attending during the week. Some of our guiding philosophy is to be less structured and more relational, to be volunteer-led, and to be donation-based. The overnight fee as well as the day fee we charge are really suggestions and only cover what we are charged by the host site. Food and programming costs (including guest leaders) are extra and are dependent on donations and offerings.

Our thanks to the volunteers who make this week happen, including planning, set-up, worship, speaking, children's ministry, cooking, and clean-up. We could not do this week without you!

On the financial side, the current WVC checking account balance is \$30,407.05 (we received a "legacy" check of \$25,000 from Holladay Park Church of God in 2019).
